#### **ORDER**

Plaintiffs and Intervenor-Plaintiffs filed a joint motion for additional time to develop the record. Defendant filed a response in opposition to the motion. The Court heard oral argument on the motion telephonically on January 15, 2025. For the reasons stated at the hearing, the motion is **GRANTED** as follows:

Final Trial Date. This case is set for a bench trial beginning at 11:00 am on Thursday, June 5, 2025, with the trial to continue if necessary on Friday, June 6, 2025. The hearing previously scheduled for February 18, 2025 and the associated briefing and affidavit deadlines imposed by the Court's 12/30/24 Order are canceled.

**Litigation Schedule.** Based on the agreement of the parties, as evidenced by the signatures of their counsel below, the Court adopts the following schedule for this case:

• January 31, 2025: Deadline for Defendant to respond to the complaints.

• February 19, 2025: Deadline for all parties to serve written fact discovery.

• March 28, 2025: Deadline for all parties to complete any fact witness depositions.

• April 4, 2025: Deadline for all parties to disclose their respective expert witnesses and the

information described in Tennessee Rule of Civil Procedure 26.02(4).

• April 18, 2025: Deadline for all parties to disclose any rebuttal expert witnesses and the

information described in Tennessee Rule of Civil Procedure 26.02(4). Rebuttal expert

disclosures are only necessary if the rebuttal opinions are outside the scope of an expert's

previously disclosed opinions.

• May 9, 2025: Deadline for all parties to complete expert witness depositions.

• May 30, 2025: Deadline for all parties to serve their witness and exhibit lists.

• May 30, 2025: Deadline for all parties to file pretrial briefs.

Obligation to Notify Court of Relevant Legislative Activity. The parties shall keep the

Court apprised of any relevant legislative activity that may impact this case.

Continuation of Injunction. The Court's temporary injunction entered on December 23,

2024 shall remain in effect until further order of this Court.
