Dear Chairman Roland:

The purpose of this letter is to respond to your allegation that someone from the Mayor's Administration altered the resolution that was provided to the State Comptroller's Office entitled "Resolution Amending the FY2016 General Fund Operating Budget to Increase the Commission's Contingency By \$107,772,795.00 to Increase Planned Fund Balance Decrease by \$107,772,795.00." After our meeting on December 30, 2015, I advised Mayor Luttrell of your complaint. Subsequently, he received your response letter to Ms. Thompson, Director of the Office of State and Local Finance, dated December 30.

The resolution requested by Ms. Folsom was handled by Deputy County Attorney Marcy Ingram. As is customary with most resolutions, the County Attorney's Office will often consult Finance to ensure the language, accounts and financial information is accurate before finalizing a resolution. At the request of Ms. Ingram, CFO Mike Swift provided input into this specific resolution.

Ms. Ingram has provided me with documentation that reflects three versions of the resolution, all drafted November 12, 2015. The first draft was provided to Mr. Swift at 12:57 p.m. (Attachment 1). Mr. Swift then provided a revised draft to Ms. Ingram timestamped at 1:59 p.m. based on his understanding that surplus funds were to be moved to the Commission's contingency fund. (Attachment 2) Ms. Ingram, knowing that the amount to be transferred was not what the Commission was seeking to do, removed the dollar amount to be transferred which represented the entire amount in the General Fund Balance, leaving it blank, and then submitted a final third version at 3:28 p.m. to Ms. Folsom in your office (Attachment 3). However, Mr. Swift never received a copy of the final resolution and he provided the CAO a copy of the resolution (version 2). The CAO provided a copy of that resolution (version 2) to the State Comptroller's Office at their request.

We want to assure you that the resolution was not altered by the Mayor's staff after the final version was presented to your office by the County Attorney's Office. Due to the conversation at the Budget Summit and the draft resolution, the Mayor's Office reached

out to the State for guidance. It is not uncommon for us to consult the State. However, we regret that our office and your office were not working directly with each other on this matter. Perhaps some confusion would have been eliminated. I hope this letter clarifies how the events transpired and that there was no intentional wrong doing on anyone's behalf.

We hope we can continue to have meaningful dialogue and help the County Commission work through issues that result in providing the best services to the citizens of Shelby County. Please let me know if you need anything further.
